John Carlo Bertot is Professor and Director of the Center for Library & Information Innovation at the University of Maryland College Park (<u>http://www.liicenter.org</u>). Since 1996, Bertot has managed and overseen the U.S. Public library Internet survey series, including survey development, data analysis, and presentation of findings. His research spans library technology planning and evaluation, information and telecommunications policy, and E-Government. He has conducted a range of research broadly related to planning and evaluation of networked services. His publications focus on topics related to demonstrating the value of library services, E-Government, and telecommunications policy. Bertot is chair of the ISO Library Performance Indicator (ISO 11629) Working Group, and member of the NISO Business Topics Committee.
